The Child-Protection Investigation Service (SIE¹) is a service of the Olga Spitzer Association, authorised and financed by the Justice Department and controlled by its Judicial Youth Protection administration (PJJ²).

It specializes in the evaluation of family environments and intervenes by decision of a Children's Judge. Our aim is to asses, with the family's participation, whether the child or teenager concerned is in danger in his family circle or his social environment. If necessary the service makes proposals for further educational assistance, taking into account the family's own resources and potential to assure the child's essential needs.


On foot

The team of the Child-Protection Investigation Service is made up different child protection professionals:

- Director, Mr DUSSART
- · Team manager, Mr ELLOUZE
- Social workers (social service assistants or specialized educators³)
- Psychologists and a psychiatrist
- Executive Assistant
- Team secretary

The Judicial Educational Investigation Mission (MJIE⁴) is a mission decided in a child-protection hearing by a Children's Judge, seeking a more complete or objective understanding of the social and family environments of a child or youth. The Children's Judge has generally received a child-protection report and orders this mission before making a decision.

This mission is designed to collect information on the development of the child or youth concerned, in order to better understand the family and extended-family relationships and the social environment and thereby evaluate his or her educational and living conditions and perspectives (schooling, physical and psychological health, leisure, social relationships).

The social worker takes care to collect information on the exercise of parental authority, the family history and social circumstances, professional, material and mental health of the sharers of parental authority.

During the mission, the child or youth meets with the psychologist in order to evaluate his or her development and essential needs.

Other family members may also meet with the psychologist.

The mission is organised to permit the different family members to express themselves, to give their different views on what could change in the education of the child (including things that may have evolved since the report or the hearing), to share their difficulties and strengths, to ask questions, give their own analyses and share their expectations.

The duration of the Judicial Educational Investigation Mission is determined by the Children's Judge. It is a judicial decision which is as binding on the families as it is on our service. It is not subject to appeal.

This mission is carried out by a multidisciplinary team (director, team manager, social workers, psychologist, psychiatrist and other potential participants such as career advisers) to guarantee a diversified and objective analysis. Together they study the collected data and make proposals to the Children's Judge, and to the family, for further assistance if necessary.
